

## Participation conditions for the Marathon Package contest

Verkehrsbüro Hotellerie GmbH is the organiser of this contest. A Marathon Package will be raffled among all participants. The winner can look forward to an overnight stay for 2 people including breakfast in an Austria Trend Hotel determined by the organiser as well as a starting place for participation in the 35th Vienna City Marathon on April 22, 2017 in the distance marathon or the half marathon.

1. Participation in this Marathon Package contest requires the disclosure of the entrant's first and last name, email address and telephone number and is only possible in accordance with these terms and conditions.

2.1 Participation is free and independent of the purchase of goods or services.

2.2 Participation in the Marathon Package contest is non-transferable and cannot be redeemed in cash, and is undertaken without exception through the website [vcm.austria-trend.at](http://vcm.austria-trend.at).

2.3 Verkehrsbüro Hotellerie GmbH reserves the right to exclude participants from the Marathon Package contest who violate these terms and conditions. This right remains unaffected even in the case of any possible compromise on the part of the participant.

3.1 Only those having their normal residence in Austria who are at least 18 years of age are eligible to take part. Employees of Verkehrsbüro Hotellerie GmbH and other persons involved in the design and implementation of this Marathon Package contest are excluded from participation.

3.2 The winner will be determined at random among all participants after the promotional period has ended.

3.3 All personal information must be correct. Participants may be excluded from participation and the drawing process should there be any suspicions as to technical or other manipulations of the Marathon Package contest. There is no entitlement to further participation, any possible claim to the prize is excluded.

4. The Marathon Package contest starts on 12.01.2018 and ends on 25.02.2018.

5. The winner of the prize will be informed promptly using the information provided upon entry (email address). The winner must confirm receiving notification of the prize without delay and submit the information required by Verkehrsbüro Hotellerie GmbH, so that the prize can be dispatched. If no confirmation has been received after one working day, Verkehrsbüro Hotellerie GmbH reserves the right to determine a new winner under the same raffle principle.

6.1 A cash payment or exchange of the prize is not possible. If a winner is already registered in one of the VCM 2018 competitions, then no paid entry fee will be refunded. The winner is free to pass on their winning starting place.

6.2 Registration for the Vienna City Marathon must be made no later than Sunday, April 8, 2018 (online registration). The registration code expires if this deadline is missed. Registration is no longer possible afterwards. It is not possible to extend the registration code or to register when the race numbers are distributed. A transfer to the following year is not possible.

If the winner waives their participation in the VCM, the overnight stay in a hotel determined by the organiser for the night of April 21, 2018 may nevertheless still be used.

The winner accepts any necessary changes to the prize, which may be caused by other factors outside the scope of influence of the companies involved in the Marathon Package contest.

Verkehrsbüro Hotellerie GmbH reserves the right to suspend the Marathon Package contest completely or temporarily, if any difficulties are encountered that may affect the integrity of the contest and/or if, due to actual, technical or legal reasons, the proper implementation can no longer be ensured.

8.1 Any obligation to pay compensation on the part of Verkehrsbüro Hotellerie GmbH and its governing bodies, employees and vicarious agents from or in connection with the Marathon Package contest, irrespective of the legal grounding, is limited to cases of intent or gross negligence, except for personal injury to the extent permitted by law.

8.2 Verkehrsbüro Hotellerie GmbH assumes no liability for damage, loss, injury or disappointment, which a participant may incur due to the Marathon Package contest. The organizer accepts no liability for participation in the Vienna City Marathon.

9. Should any individual elements of these participation conditions be or become invalid, this does not affect the legal validity of the remaining conditions.

10. The organisers' decision is final. The agreement is subject to Austrian law. The exclusive court of jurisdiction is the competent court in Vienna, Innere Stadt.
